



PUBLIC AGREEMENT
on the procedure for publishing authors' articles

1. General Provisions

1.1. This document constitutes a public offer by the publisher of the journal "Democratic Governance" (hereinafter — the **Publisher**) to an indefinite number of persons to enter into an agreement under the terms set out below (Article 633 of the Civil Code of Ukraine).

1.3. The publication of the text of this Agreement on the official website of the journal constitutes an offer to conclude an agreement under the conditions provided herein.

2. Parties and Roles

2.1. The **Author** is a natural person who has created an article and submits it for publication; within the scope of this Agreement, the Author acts as the **Licensor**.

2.2. The **Publisher** is the editorial office of the journal; within the scope of this Agreement, the Publisher acts as the **Licensee**.

3. Procedure for Acceptance

3.1. The Agreement is concluded by full and unconditional acceptance of its terms, without any amendments, exclusions, or reservations (Article 642 of the Civil Code of Ukraine).

3.2. Acceptance shall be deemed to occur when the Author submits their materials for publication in the Licensee's editions following prior approval of the article's content with the editorial office.

4. Subject of the Agreement

4.1. This Agreement defines the procedure for publishing authors' articles in the journal Economics, Entrepreneurship, Management and the terms under which a Licence for the use of the work is granted.

5. Licence and Scope of Rights

5.1. The Author retains copyright in their work and grants the Publisher the right of first publication under the terms of the **Creative Commons Attribution International (CC BY)** licence.

5.2. Within the framework of this licence, the Publisher shall have the right to:

5.2.1. publish the articles in English and distribute their printed versions;

5.2.2. translate articles written in Ukrainian into English and distribute the printed versions of such translations;

5.2.3. distribute electronic versions of the articles, including English translations (for articles written in Ukrainian), by any electronic means, including publication on the journal's official website, in databases, repositories, and similar platforms.

6. Confirmation of Rights Allocation

6.1. The publication of the author's material in the journal Economics, Entrepreneurship, Management constitutes confirmation of the allocation of rights between the Licensor and the Licensee.

7. Publication Procedure

7.1. Preliminary approval of the article's content between the Author and the editorial office.

7.2. Submission by the Author of materials for publication (which simultaneously constitutes acceptance of the terms of this Agreement).

7.3. Publication and/or distribution of the article by the Publisher in accordance with Clause 5.2.

8. Liability of the Parties

8.1. In the event of non-performance or improper performance of obligations under this Agreement, the Parties shall bear liability in accordance with the applicable legislation of Ukraine.

9. Dispute Resolution

9.1. Any disputes or disagreements arising in connection with the performance of this Agreement shall be resolved through negotiations between the Parties.

9.2. If agreement cannot be reached, the dispute shall be settled in court in accordance with the laws of Ukraine.

10. Final Provisions

10.1. In all matters not expressly regulated by this Agreement, the Parties shall be governed by the legislation of Ukraine.

10.2. Submission of materials by the Author constitutes full and unconditional acceptance of the terms of this public offer.
